Invitation for Bids for the: **Construction of 15 bed hospital at Naudada, Annapurna Rural Municipality, Kaski**

1. The Government of Nepal [GoN] **has allocated funds** towards the cost of **Construction of 15 bed hospital at Naudada, Annapurna Rural Municipality, Kaski** and intends to apply part of the funds to cover eligible payments under the Contract **Construction of 15 bed hospital at Naudada, Annapurna Rural Municipality, Kaski and ARM/W/B/2077/78-02**. Bidding is open to all eligible as per Section V of bidding document.
2. Annapurna Rural Municipality invites sealed bids or electronic bids from eligible bidders for the construction of Project mentioned in table below under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Annapurna Rural Municipality, Annapurna – 2, Kaski** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document of NRs **10,000.00 (Ten Thousand Rupees only)** in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Pre-bid meeting shall be held at **Office of Annapurna Rural Municipality, Machapokhari, Kaski at 13 hrs on 5th Poush 2077 (20th December, 2020)**.
7. Electronic bids (one Technical Bid and another Price Bid) must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp or before **12 Hrs. on 16th Poush 2077 (31st December, 2020)**. Bids received after this deadline will be rejected.
8. The Technical bids will be opened electronically in the presence of Bidders' representatives



who choose to attend at **13 Hrs on 16th Poush 2077** at the office of **Annapurna Rural Municipality**. Bids must be valid for a period of **120 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Four Million only**, which shall be valid for 30 days beyond the validity period of the bid

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
